In this regard, it is to inform you that the Government recognizes an Educational Institution upto 8th Class and subsequently the Institution is proposed for up-gradation to Higher Classes i.e 9th & 10th after determining the Academic Viability for running 9th & 10th class and the affiliation is granted by the State Affiliation Committee.

The J & K State BOSE has No Objection for issuance of **No Objection Certificate for affiliation with CBSE by the Government**, if the Institution is covered under the guidelines of State Advisory Committee constituted by the Govt. of Jammu & Kashmir, Department of Education vide Order No:- 274-Edu of 2007 dated:- 03-08-2007 as given below:-

1. Fully aided or partly aided private schools; including those which have been provided state-land on lease or land at subsidized rates should in no case be granted No Objection Certificate to fully affiliate with any Board other than Jammu and Kashmir State Board of School Education. This will enable the State Board retain elite schools and help it to grow professionally and thus serve the people of the State better.

Provided such schools may be allowed to seek affiliation with other country or foreign Boards for running Courses that are relevant for meeting challenges of 21st century but are not offered by the State Board.

2. Cases of unaided private institutions for grant of No. Objection Certificate to affiliate with Board/s other than Jammu and Kashmir State Board of School Education be considered only and only if they fulfil the following conditions. :-

- a) 50 % or more of its total number of students are children of central government employees, defence personnel or other people whose services are transferable to places outside the state; people who migrate in connection with business or services in private sector.
- b) Reserve a minimum of 10 % seats in all for children of economically backward peoples every year and allow them free ship. The list of such children shall be provided by the department of education every year in the beginning of the session.
- c) Gives due consideration to qualified state subjects while appointing teaching and non-teaching persons
- d) Has at least two members representing the Department of Education Government of Jammu and Kashmir on its Managing Committee. The members will be nominated by the Education Department
- e) Undertakes to make arrangements for teaching of mother tongue(s) of the children.
- f) Implements the Three Language Formula.
- g) Follows a contextualized curriculum which has local culture traditions and ethos incorporated in it.
- h) Undertakes to follow instructions which the State Government may issue from time to time for ensuring quality education in the state.
- i) Gives an undertaking that in the event of not fulfilling the above conditions NOC granted may be withdrawn at the risk and responsibility of the Institution


